AN ACT TO CONSTRUCT SPEED BUMPS ON ALL TENNESSEE HIGHWAYS TO CURTAIL SPEEDING

1 2	BE IT ENACTED BY THE TENNESSEE YOUTH LEGISLATURE:
2 3 4 5 6 7 8 9	Section 1) Terms in this act shall be defined as follows: Speed Bump: an obstacle made of plastic or asphalt that curtails drivers from driving too fast on a given road Highway: A state-funded or federally-funded road that connects cities and towns, allowing drivers to drive long distances without significant interruptions
10 11 12 13	Section 2) In order to curtail excessive speeding, all highways in the state of Tennessee shall be required to have at least one speed bump in each lane at least every 10 miles.
14 15 16 17 18 19	Section 3) The State of Tennessee states that we believe that speeding is a major issue in the state of Tennessee that must be stopped. The State of Tennessee believes that by placing speed bumps on all highways, we can cut the rates that drivers speed on our highways in half.
20 21 22 23 24	Section 4) Speed bumps must be at least four inches high, in order to guarantee that they can be a successful deterrent too speeding. They also must be at least 12 feet from front to back. Speed bumps must also curve upward in a flattened upside-down u shape.
25 26 27 28	Section 5) The construction of these speed bumps shall be overseen by the Tennessee Department of Transportation, which shall be given a budget increase of \$10,000,000 to oversee this project.
29 30 31	Section 6) All speed bumps on highways must be painted yellow and black in a diagonal stripe pattern in order to allow for visibility.

- 35 Section 8) This act shall take affect January 1, 2021, the general
- 36 welfare requiring it.
